Five Island OCEANMAN Regulations

These regulations establish the basic rules of participation for swimmers registered in the OCEANMAN Five Islands. By registering, participants accept all the clauses described here.

1. Competitions and Dates

The circuit will be made up of the following 5 official competitions:

1. Vieques · Puerto Rico	27 - 28	June 2025
2. San Andres · Colombia	25 - 27	July 2025
3. Cozumel · Mexico	2 - 3	August 2025
4. Cayo Santa Maria · Cuba	9 - 7	September 2025
5. Bayahibe · Dominican Republic	11 - 12	October 2025

2. Registration in the Circuit

Registration for the circuit must be carried out using the official form available on the website of each circuit venue.

The price list is in Annex II of this document.

If you are already registered at one of the circuit venues and wish to enter the circuit, you have to manage inclusion to the circuit in a personalized way through the contact: fiveisland@oceanmanswim.com

3. Circuit Five Islands Oceanman

The purpose of the circuit is to promote open water swimming, promote healthy habits, encourage sports participation and establish an annual ranking based on the performance and participation of swimmers, taking into account the following options.

- Option 1: General male and female ranking plus financial prizes.

- You must register in the circuit to compete in at least 4 of the 5 competitions that the circuit consists of.
- The points obtained for the circuit will be the best 4 times of the 5 competitions you compete in.
- It is mandatory to always score points at the same distance at all venues on the circuit.

 You must participate and finish kitten in 4 of the 5 venues belonging to the circuit in the 2025 season.

What does this option 1 include:

- Classification in the ranking with the points obtained from the general classification of each of the venues where you have participated. Based on the points table in Annex I.
- Obtaining the medals that make up the Five Island circuit.
- Circuit Merchandising Bag at the end of the 4th competition held.
- Right to opt for prize money based on your circuit ranking classification.
- Certificate of Participation to the circuit.

The Prize money will be applied whenever in the circuit ranking in the OCEANMAN, HALF OCEANMAN AND SPRINT distances, there are 10 or more participants eligible for prizes, based on the points obtained in each of the circuit venues during the 2025 season.

- Option 2: Certificate of participation and achievement of medals at circuit venues.

- You must register with the circuit to compete in at least 5 of the 5 competitions that the circuit consists of, in the 2025 or 2026 seasons.
- It is mandatory to participate in a minimum of 2 of the 5 venues that make up the circuit during the 2025 season, the rest until all 5 are completed in the 2026 season.

What does this option 2 include:

- Obtaining the medals that make up the Five Island circuit.
- Circuit Merchandising Bag at the end of the 3rd competition held, regardless of the season in which you accredit said participation.

4. Protection of Personal Data and Image Rights

In compliance with current regulations on data protection, participants are informed that their personal data will be processed exclusively for organizational and sporting purposes. Likewise, by registering for the circuit, participants authorize the organization to use their image in photographs and videos for promotional and dissemination purposes of the event on social networks, media and digital media.

5. Acceptance of the Regulations

Registration in any of the circuit events implies full acceptance of these regulations. The organisation reserves the right to modify aspects of it for justified reasons, informing of said changes in advance. For matters not contemplated in these regulations, the general regulations of Oceanman will apply. Link to the regulations
